A bibliographical account of *Icones plantarum sponte nascentium in regnis Daniae et Norvegiae*, better known as *Flora danica*

ALMOST 400 YEARS AGO, in 1588, a modest volume of 133 pages of text and 9 woodcut illustrations was published in Frankfurt am Main; its title reads: *Sylva hercynia, sive catalogus plantarum sponte nascentium in montibus et locis plerisque Hercyniae sylvae, quae respicit Saxoniam*. The publisher, Johann Feyerabend, apparently was not fully confident of the work's commercial success, and thus he had it appended to one by the well-known author Joachim Camerarius (1534-1598): *Hortus medicus et philosophicus*, which was published in the same year; Camerarius functioned also as editor for the *Sylva*. Very likely neither the publisher, nor the editor, nor the author, the German physician Johann Thal (1542-1583) from Nordhausen, who did not live long enough to see his work in print, realized that this account of the plants of the Harz mountain range in central Germany would later be considered the first and by no means the least in the long row of publications of the sort concerned with the inventory of native plants of a given geographical region, generally designated by the term "flora."

Even earlier than Thal's flora, two works with floristic contents had been published: *Il viaggio di Monte Baldo dalla magnifica citta di Verona. Venezia, 1566*, by Francesco Calzolari (1522-1600), and . . . *Aigentliche Beschreibung der Raiss, . . . in die Morgenländer . . . S.l., 1583*, by Leonhard Rauwolf (ca. 1540-1596), but both publications are travel works in the first instance, and only

part of each text deals with native plants.

While this is not the place for a general history of floras, or one of the floristic exploration of a given single area, the mentioning of Thal and the humble beginnings of a most important category of botanical literature should serve as a reminder that will lead to a greater appreciation of the characteristics of the work selected for the present essay.

Flora danica, begun in 1762, represents the first attempt to publish a comprehensive national flora, with the goal to enumerate and illustrate all the native taxa growing within the country's boundaries. However, while the majority of the floras of this kind place their main emphasis on the text, with the plates playing only a secondary role, the *Flora danica*, from its very start, chose the illustration of each plant taxon to be of prime importance, while the text was to perform a more supportive function, restricted to presenting the names of the plants, including their synonymies, and their habitats and localities. The choice of the illustration rather than the description as the standard for treatment is aptly signified by the formal title selected: *Icones plantarum sponte nascentium in regnis Daniae et Norvegiae, . . .*

The establishment of such a priority, in order to be successful, required the strong and steady commitment of a sponsor, and such was fortunately available in the persons of five successively reigning monarchs

of the Royal House of Denmark who provided both the financial and moral support. The merit for convincing King Frederik V of Denmark (1722-1766) to adopt the proposed plan and support the project clearly belongs to Georg Christian Oeder (1728-1791), who became the flora's first author and editor, from 1762-1771. Oeder, in 1752, had been actively encouraged to come to Copenhagen from Schleswig by Count Johann Hartwig Ernst Bernstorff (1712-1772), the leading Danish statesman of the period, and it was Count Bernstorff who made available financial means which enabled Oeder to travel to the continent to find artists and craftsmen for his work and to collect plants in Norway, prior to publishing the flora. In accordance with the methods of reproduction available in the second half of the 18th century, copper-plate etchings and engravings were chosen to illustrate the plants, and because of the high costs involved, the subscription method of publication was selected. Each fascicle was to consist of 60 plates with accompanying text, and five fascicles were to form one volume. The plates were available either hand-colored or plain. The first fascicle, though dated 1761, appeared in 1762, and thus began one of the most successful botanical publications ever. The only change subsequently instituted was to have three (rather than five) fascicles form one volume. The switch was announced in fascicle 5, 1766, and title-pages for volumes 1 and 2 were issued at the same time, both dated 1766.

In spite of difficulties caused by later changes in the authorship and editorship, a more or less steady flow of fascicles was produced over the next 121 years—altogether 54 fascicles (18 volumes) with 3240 plates and 366 leaves of text (including fascicle and volume title-pages). The costs for collecting

the specimens of plants to be illustrated, the artists who designed the drawings, the copper plates and the craftsmen who did the engraving and hand-coloring, were all borne by the King, while the paper and printing costs had to be defrayed by the author/editor in charge at the time. This explains why no commercial publisher's imprint is found in the work at all; only printers' and (in earlier fascicles) book-dealers' names are stated. It may also account for the various reprints of title-pages and/or whole fascicles of text observed in the copy at the Hunt Botanical Library, which served as the catalyst for pursuing the present study.

In addition to Oeder, five other botanists were mainly responsible for the continuous production of *Flora danica*: Otto Fridrich Müller (fasc. 11-15, 1775-1782); Martin Hendriksen Vahl (fasc. 16-21, 1787-1799); Jens Wilken Hornemann (fasc. 22-39, 1806-1840); Frederik Michael Liebmann (fasc. 41-43, suppl. fasc. 1, 1845-1853) and Johan Martin Christian Lange (fasc. 44-51, suppl. fasc. 2-3, 1858-1883). Fascicle 40, 1843, was jointly edited by Joachim Frederik Schouw and Jens Laurentius Mostue Vahl. However, the picture is much more complicated than the dates just mentioned suggest. Details are explained on p. 000. For other persons involved, the treatment given under Floristic contributors (pp. 000-000) should be consulted.

The geographical region covered was by no means restricted to Denmark proper, but included Norway (up to vol. 10, 1823, frequent references; then occasional mention, and then full coverage again in the supplement, 1853-1874) and substantial portions of northern Germany that were at one time or another connected with the Royal House of Denmark (up to vol. 15, 1861, frequent references; from then on only occasional mention). The changing

coverage, with accompanying variations in the text of the title-pages, reflects Danish dynastic history during the long period of 122 years. The supplement extended the area beyond that of the Danish realm to include also Sweden, which may come as a big surprise to many readers. Not mentioned on the title-pages, but well represented indeed, are plants from Iceland, the Faeroe Islands and Greenland. Thus substantial portions of northern Europe and arctic North America are covered in this flora.

While the majority of copies were issued entirely in Latin, a smaller number had the text partly in Danish or German. All three editions were published concurrently, but the edition in German terminated with vol. 15 in 1861, again a consequence of political developments.

The heading of the (Latin) text for fascicles 1-43 (1762-1852) and supplement fascicles 1-3 (1853-1874) reads uniformly: *Nomenclatura et loci natales plantarum*; it changed to: *Descriptiones succinctae, synonyma selecta et loci natales plantarum* (fasc. 44, 1858); then it became: *Nomina et loci natales, adjectis synonymis nonnullis brevique descriptione plantarum in hocce fasciculo depictarum* (fasc. 45-48, 1861-1871; fasc. 51, 1883); until finally the version adopted was: *Nomina et loci natales, adjectis synonymis brevique descriptione plantarum depictarum* (fasc. 49-50, 1877-1880). The first change in the headline coincided more or less with a shift from providing just the synonymy (often consisting of phrase names or later of brief diagnostic statements taken from previous authors) to establishing a terse and concise diagnosis of each taxon, resulting generally in an increase in the number of pages per fascicle (for details, see the pagination statement below).

One important point not yet made is that each fascicle included representatives of both higher and lower plants. The number of new taxa described is limited, but they are very difficult to recognize, because in most cases they are not marked as such; only the lack of an author citation or a reference to a place of prior publication indicates a new taxon or a new combination. In some, but not all, of the fascicles written and edited by Hornemann the designation "(mih)" is found. The term "(nob.)" appears in the early fascicles by Lange (44-45, 1858[1859]-1861); later he used the abbreviation "Lge." for new taxa, and only in fascicle 49 (1877) did I find the indication "n. sp." used by him (however, new varieties are still unmarked). Liebmam used the abbreviation "Liebm." for new taxa in supplement fascicle 1 (1853). However, diagnoses provided by contributors other than the editors are generally well marked.

In spite of this later shift in emphasis to improve the quality of the text, the main importance and fame of *Flora danica* rest with its illustrations, which are indeed impressive in both number and quality, and also, if one wants to introduce some aesthetic judgment, in beauty. The tone was set by a team of father and son, the Rösslers (Michael, 1705-1777, engraver and etcher; Martin, 1727-1782, draughtsman), both originally from Nuremberg, who were responsible for most of the plates in fascicles 1-10 (1762-1771) under Oeder's direction and also some of the plates in fascicle 11 (1775). Nissen (vol. 1: 227. 1951) rated their plates among the best, not just for the present work, but in all of botanical illustration! Under the editorship of O. F. Müller and M. H. Vahl, Müller's brother Christian Friderich, 1744-1814, took over both functions and produced the drawings

and plates for most of fascicle 11 (1755) and for fascicles 12-21 (1777-1799). He was in time succeeded by Johann Theodor Bayer, 1782-1873, who spent most of his active career as a draughtsman and engraver for *Flora danica* and produced about 1500 of the plates published in fascicles 22-46 (1806-1867), under the successive editorships of Hornemann, Liebmann and Lange. For further details, see accounts in Nissen (vol. 1: 227-228. 1951; vol. 2: no. 2249. 1951) and Sitwell & Blunt.

The illustrations of the plants are often life-size, if that was possible, or at least depict some life-size part of the plant. In many cases, reduced general habit sketches are included, and these are usually not colored, so that technically speaking quite a few of the plates may be designated as "partly colored." All plates also show analyses of floral or other important parts, separately and often enlarged. Especially for cryptogams, some plates illustrate more than one taxon—up to three figures (more commonly two) per plate. The plates are numbered in the top right corner with consecutive Roman numerals (except for the supplement which has its own numeration), while the figures are designated with Arabic numerals. No binomials or vernacular names appear on the plates, which also lack indications of artist and craftsman. However, since the text is arranged according to the plate numbers (also in Roman numerals, but quoted below with Arabic numerals for convenience), it is not too difficult or time-consuming to find the name for each plant illustrated. No complete index enumerating all the plates was published as part of the flora, only a 10-page partial index, usually bound with volume 1 but published considerably later. However, there are plenty of partial indices published separately and by various authors, and there also exists a

complete index produced by Lange in 1887. All these works are quoted below in the bibliographical treatment, provided they came out as books or separates.

There are few works that can match or surpass the importance of *Flora danica*. *Flora batava* immediately comes to mind; it was started in 1800 by Jan Kops (1765-1849) in Amsterdam and finished in 1934 in 's Gravenhage, with 28 volumes of text in 4° and 2240 colored plates, with an even larger number of authors and editors involved and spanning 135 years, 13 more than *Flora danica*. However, the quality of its illustrations is more uneven, and they are generally not of the same high calibre as those in *Flora danica*. And then, of course, there is the most famous of all floras, *Flora brasiliensis*, edited in succession by Carl Friedrich Philipp von Martius (1794-1868), August Wilhelm Eichler (1839-1887) and Ignatz Urban (1848-1931), consisting of 3837 mostly black and white plates in 16 volumes in 2° and 20733 columns of text, published between 1840 to 1915. But then again, this work does not really compare: it is the result of teamwork, with 65 text contributors and also many botanical artists employed, while *Flora danica* is primarily the achievement of a few individual botanists and botanical artists who gave all or the better parts of their professional lives to produce one of the most respected and esteemed works in botanical literature. To their memory, and to that of five successive kings of Denmark (Frederik V, 1722-1766; Christian VII, 1749-1808; Frederik VI, 1768-1839; Frederik VII, 1808-1863; Frederik VIII, 1843-1912) who provided the support so essential to the success of this work, the following formal treatment is dedicated.

Variants: Judging from the information obtained from a study of the copy at HBL and the remarks given in NUC, many copies not representing the ideal state as described above should exist. Apparently these copies were assembled at a later date, from remnants of the text of the original edition and reprints as needed; in the HBL copy even several fascicles of the editions partially in German or partially in Danish are represented. The plates always have been available, and as a matter of fact are still being printed, e.g. for the use of the Royal Danish Porcelain Manufacture. Also several books (after 1847) have been published which include illustrations printed from the original copper plates of the "Flora danica" (Information courtesy of Mr. Peter Wagner, Copenhagen).

The information on reprinted volumes and fascicles presently available is rather limited; however, it certainly may stimulate further bibliographical research to present here the data for the copy at HBL and to compare them with those for copies of the original edition (specifically the copy at C).

In summary, the earliest reprint present in the copy at HBL is the title-page of vol. 9, dated 1820, and the latest reprint found is the title-page of vol. 16, which bears the date 1933 on its verso. Mr. Peter Wagner of Copenhagen reports (*in litt.*, dated 22 Aug. 1978) that the earliest reprints were instigated by Prof. Hornemann, from 1828 to 1831. While this period would nicely fit with regard to the reprint of the title-page of vol. 7, the possible date of the reprint of the title-page of vol. 8 (1823) and the printed date of the reprint of the title-page of vol. 9 (1820) do not agree with this statement. On the other hand, Hornemann was responsible for the preparation of the text from 1806-1840, and it is quite possible that the earlier reprints were also produced under his direction. In a recent letter (dated 22 Feb. 1980) Wagner hints that even earlier reprints might exist, especially from the period when O. F. Müller was responsible for publication (1775-1782). However, no definite information proving this fact has been uncovered yet.
