Uncut and unopened copies

The term "uncut copy" is frequently used in bibliographic descriptions of books, and to the non-bibliographer its use may be confusing. It does not refer to the cutting with the paper knife of the bolts, that is, of the folds which connect the leaves at the outer margins. As long as these are uncut, the book is properly referred to as "unopened." The term "uncut" is applied to a book whose edges have not been cut or trimmed by the binder, thus making all leaves of uniform size. This is done with a trimmer, or

paper cutter, known also as a "guillotine."

The term "untrimmed" might have been more descriptive than is "uncut," but the use of the latter is well established in bibliography. Another point is that traces can often be found in books, otherwise untrimmed, of a slight trimming of leaves which originally protruded exceptionally far, or for reasons of preliminary sewing, where the top edge of the book was made smooth. Nevertheless, since a majority of the leaves are untrimmed, I designate these copies as uncut. The reconstruction of the original sheet is essential for determination of its size, and the bibliographical format.

Uncut copies are important to the analytical bibliographer because the original sheet can be reconstructed by the irregularities left by the paper

knife and the complete watermark can be investigated.

Unopened copies can serve the same purpose, but no scientific value is lost by opening the book, provided this is done so that the original folding of the sheet can easily be recognized. On the other hand, unopened books in pristine condition, as collector's items, usually fetch much higher prices than do opened ones.
